Warren Brodine has served as CEO of Chicago Family Health Center since September 2008. Prior to that he worked for a national consulting firm focusing on hospitals and outpatient care, two other federally-qualified health centers, a state association of community health centers, a statewide Planned Parenthood affiliates office, and a port authority. As Chief Executive his priorities have been building financial reserves, increasing fundraising, modernizing technology, and establishing up to date care facilities. In addition, the Chicago Family Health Center has focused on developing comprehensive coordinated care models for the full life cycle of care.

Planned Parenthood of Orange and San Bernardino Counties (PPOSBC)

Jon Dunn has served as President/CEO of Planned Parenthood of Orange and San Bernardino Counties (PPOSBC) since October 1993. Under Jon's leadership the affiliate has become one of the largest in the nation, serving 160,000 unduplicated clients annually with a broad array of reproductive health, WIC and education services. Jon is currently the Secretary of the Affiliate Chief Executives Council, a national organization comprised of the more than 70 Planned Parenthood CEOs from across the country. He also serves on the Board of Planned Parenthood Affiliates of California. Jon is a former board member of CFHC and a former Chair of the Orange County Coalition of Community Clinics. Jon has a Masters Degree in Social Work from Boston University and a Masters Degree in Business Administration from Northeastern University.

Samantha Jones, MPH, Senior Program Coordinator

California Primary Care Association (CPCA), Patient-Centered Health Home Initiative

She served as Project Director for a biomedical support group actively engaged in worldwide HIV clinical trials research working with 255 researchers located in Africa, Thailand, India, Brazil, and multiple sites throughout the United States.
