On June 20, 2019, a motions panel of this Court issued a published order staying the preliminary injunction issued by the District Court in this case (“Stay Order”). The Stay Order allows regulations to take effect which result in irreparable harm to plaintiffs in this case. Pursuant to Federal Rule of Appellate Procedure 35(b) and Ninth Circuit General Order 6.11, Plaintiffs-Appellees Essential Access Health and Dr. Melissa Marshall (hereinafter “Plaintiffs”) respectfully move for en banc reconsideration of the Stay Order.

Plaintiffs’ case has been consolidated with a companion case, *State of California v. Alex Azar & U.S. Dept. of Health and Human Services*, Case No. 19-15974. The State of California (“California”) has, concurrently with this motion, filed a motion for reconsideration en banc. Case No. 19-15974, Dkt. 28. Plaintiffs adopt by reference the substance of California’s motion pursuant to Federal Rule of Appellate Procedure 28(i). For the reasons stated in California’s motion, the Court should grant en banc reconsideration, vacate the motions panel’s Stay Order, and deny Defendants’ motion for a stay of the preliminary injunction pending appeal.
